1. Roger Powe- Variance

The City of Foley Board of Adjustment and Appeals has received a request for a variance for Article 14.1.2 D, required minimum side yard setbacks in a R-1A zone. Property is located N. of E. Franklin Ave. and W. of S. Pecan St. Applicant is Roger Powe.

Mr. Stuart Smith stated the request is for a setback variance.

Chairman Kimsey asked if there would still be 20' separation between the buildings.

Mr. Smith stated there would be 20' between the houses which meets the National Fire Code requirements.

Chairman Kimsey stated they are requesting 10' side yard setbacks instead of the required 12'. He asked if there were any members of the public to speak on the item. There were none.

2. Beach Express RV & Storage- Use Permitted on Appeal

The City of Foley Board of Adjustment and Appeals has received a request for a use permitted on appeal for Article 18.1.2 B, to allow RV/Boat and self-storage in a B-1A zone. Property is located S. of County Rd. 20 and W. of the Foley Beach Express. Applicant is S.E. Civil Engineering and Surveying.

Mr. Larry Smith explained he is the Civil Engineer for the project. He stated an update plan was provided to the board members and staff. He stated a reconfiguration had to be done to accommodate the required driveway placement. He explained there will be offices in the
