You have been charged with a traffic offense within the jurisdiction of the Municipal Court of Foley, Alabama. You have the right to a trial. The date entered on the citation just above the space for your signature is a plea date. If you have not taken care of the citation in another manner prior to the Court date, you must be in court at the Foley Justice Center located at 200 East Section Avenue, Foley, Alabama at 1:00 pm on the date specified on your citation. Failure to do so may result in arrest, additional expense and the loss of your driver's license.

If you **have not** been convicted of two or more traffic violations within the past year and are charged with one of the offenses listed and wish to plead guilty and pay the fines and costs, you may do so by mail or in person at the Municipal Court Clerk's office. Your payment must be mailed in time so it will arrive at the court clerk's office by the appearance date/plea date shown on the citation.
